Notes: All figures based on standard income support and housing benefit rates as they apply from April 2006. The figures for lone parent households are for post April 1998 claimants. Figures are for cases without child care costs eligible for assistance under the working families tax credit scheme. The housing benefit allowances and earnings disregards are set against net earnings (and child benefit and tax credits). For consistency all figures assume an adult working 30 or more hours per week, unless this implies earnings below the level of the minimum wage at April 2006. The cases based on an adult working less than 30 hours per week are shown in *italics*. For single people and childless couples working less than 30 hours it means that they do not qualify for working tax credit, and this has a significant impact on the earnings level at which they cease to qualify for housing benefit.
